

Newsletter 4 - BdP national Jamboree 2022



International Evening

What:

- Prepare a program for the other (German) participants
- as a presentation or a join in activity
- Presentation of a country-typical or culture-typical action
- Everything is possible: food, music, dance, games, performance, crafts, ...
- You can determine the duration yourself. However, the action should last at least 10 minutes and at most an hour.
- Please note that no alcohol may be served or consumed during the international evening.

How:

- think of a program that represents your culture
- Tell us:
 - What are you doing?
 - How long do you need?
 - What do you need? (Tables, chairs, cooking facilities, stage, free space outside, ...)
 - Please remember that your program will take place inside or in front of tents. There is little electricity available.

Where:

- Tent cafes in the sub camps
- In the attached form you can have a look in which tent cafe you will have your presentation. There you can also see the other groups in your cafe.

When:

- Saturday, August 6th, 8-10 p.m

Who:

- The international guests ;)
- You can plan the evening in your cafe together with the other international groups in that cafe and your German partner groups.
- In each sub camp is one person responsible for your well being. This person will help you coordinate the international evening with the other international groups in that cafe.



Bundeszeit

Showcase your culture!

Every afternoon throughout the Bundeslager there is a time window of 2 hours, called "Bundeszeit" (4pm - 6pm). During this time, participants freely explore different locations on the camp ground, including the "market place" with the international center. We would like to showcase the diversity of our participants by having a few international groups every day, offering traditional food, offering program for people to join in (like dances, games, etc).

Please let us know until June 30th what you would like to contribute, how often you would be willing to do it and what you will need to do so (material, location and further support). If you should be interested in offering food/drinks, please refrain from bringing alcohol as well as meat-based dishes.

Snack around the world

On our Bundeslager we will have the program: "Snack around the world" for and from Cub Scout leaders, which will be part of a program in the Cub Scout tent during the above mentioned Bundeszeit. You are warmly welcome to join this program. If you want you can even bring country-specific sweets and snacks and give them to us in the international tent on the first day of arrival. If you bring receipts of max. 15€ it will be reimbursed. Please tell us until 30.06. whether you will bring something.

Invoices - payment

You have now successfully bought tickets for the Bundeslager. You will soon receive the invoice from your German partner group. On the invoice you will find both the account details and the payment deadline for your transfer. Please adhere to this payment deadline, as your partner group has already advanced the fee for you and you will otherwise cause them financial difficulties. For our billing, it is important that you always use the reference "Jamboree 2022" without any additions for your transfers. If your partner group has applied for grants and these are left over at the end of the camp, they will support you with camp fees and travel expenses by transferring a portion of the amount back to you after the camp under the same reference. The refund is not guaranteed and the amount is not yet foreseeable and must be coordinated with your partner group.



Insurance

When you bought your ticket, you stated that you have international health insurance for all participants in your group. Please send us the documents as proof of this international health insurance to bundeslager@pfadfinder.de by June 30th, 2022 at the latest. If you have not done this or if we have not received any proof by June 30th, 2022, we are obliged to take out international health insurance for you and to charge you for it. Furthermore, we have to take out accident and liability insurance for all camp participants. This insurance costs 0,28€ per person and day of the international meeting with your partner group. This adds up to 2,80€ per person for the National Jamboree plus 0,28€ for each additional day that you are traveling in Germany with your partner group. Your German partner group will first receive and pay the bill for this. The insurance costs can be paid by the grants your partner group applied for. If you/your partner group have not applied for any grants, your partner group will forward this small invoice to you.

Health sheet

Attached you will find a health sheet. This form must be filled out by all participants, signed by the legal guardians and brought to the camp. It serves as the basis for all medical treatment by our camp medical team, as well as for medical treatment in the hospital.

Travels within Germany

The central arrival and/or departure with the coaches from or to your partner group home are now being organised. It is no longer possible to book seats for this. We have received your shuttle bus bookings for arrival and departure as well. We will let you know the exact place of departure in Wolfratshausen. Contact persons will also be available on site. Please note that due to the high number of registrations at 3 pm and 4 pm on the day of arrival, there may be waiting times. We have taken your preferred times of the shuttle departure into account as far as possible and, if necessary, booked earlier in the event of overbooking. There are still a limited number of places available for arrivals with departures in Wolfratshausen at 6 pm. If necessary, please send an email to bundeslager@pfadfinder.de.

If you want to travel to the camp site by public transport, you can take the 379 bus from Wolfratshausen S-Bahn station in the direction of Bad Tölz and get off at the "Aug, Wackersberg" bus stop. The first bus leaves at 9:21 and then departs every 2 hours. The last bus leaves at 21:21. The walking route from the bus stop to the campsite (30 minutes) will be signposted.

There are two emergency numbers specifically for arrival/departure. These are reachable only on 28./29. July and on 8./9. August exclusively for problems with the departure or the coaches during the journey (e.g. breakdown, delay, unusual driving style etc.) and can only be reached by telephone (no text message or WhatsApp).

Registration on the camp side

In addition to the online registration, you have to register again directly at the camp. Please contact the administration (Verwaltung) as soon as possible after your arrival at the camp site. There you get event wristbands for all participants in different colours depending on their age (under/over 16 years). Since we first have to create the technical requirements for registration, an earlier arrival of the groups (even for pre-tours) is not possible.

Corona Update 15.05.2022

Dear international guests,

We learn more and more how to deal and cope with the covid-19 pandemic and even with regulations being lifted in Germany, we want to make sure, that the BdP national Jamboree is a safe place for everyone attending. We take the safety regarding covid-19 very serious and will have measures in place to ensure that we don't spread the virus. Those measures can change, if the situation requires it. It is our collective responsibility to make sure, that we don't expose ourselves or others to unnecessary risks. As scouts we take care of each other, that applies to every interaction, on the small and the big scale.

We want to enjoy the BdP national Jamboree with all of you - to make that possible we need to take precautions, while aiming for a carefree Jamboree, in the safest way possible.

As the restrictions in Germany have been lifted, it will be possible for unvaccinated people, regardless of their age, to attend the BdP national Jamboree. This is the case at this point of time, all measures will steadily be evaluated. We will inform you of any changes to the attendance policy if they occur.

Nonetheless we strongly urge you to get vaccinated. The vaccine is protecting you from severe illness and will make our national Jamboree a safer place for everyone.

We don't want to exclude people from attending the national Jamboree, especially for immune compromised participants or those with pre-existing conditions we want to limit the risks as much as possible. As scouts we take care of each other, getting vaccinated is part of that.

Rapid tests are a way to monitor the spread of the covid-19 virus. To further ensure the safety at the national Jamboree we will have a rapid-test-strategy in place. Complying to the test-strategy is mandatory for anyone attending the BdP national Jamboree.

Covid-19 and the BdP national Jamboree - conditions for participation

Under the current laws and restrictions the attendance of the BdP national Jamboree is possible under the following regulations:

- every person attending has to be vaccinated, recovered or tested (3G)
- on arrival every person attending has to have a negative Covid-19 rapid test result from an official state registered test centre not older than 24 hours
- if a person shows any cold or infection symptoms, they will not be allowed to attend the BdP national Jamboree

We will follow the 3G-Rule for the BdP national Jamboree. 3G in Germany means 'Geimpft, Genesen, Getestet' (vaccinated, recovered or tested).

We recommend the AHA-L-Rule and Vaccinations

AHA-L stands for

Abstand halten: keeping distance to others, preferably at least 1,5m

Hygiene: keeping hygiene, washing hands

Alltagsmaske: we highly recommend using masks (preferably FFP2/N95 or medical masks), you will be required to bring masks to the BdP national Jamboree

Lüften: ventilation

We will try to implement the AHA-L-Rule as best as possible in our hygiene-concept for the Jamboree. In addition to that we want to urge you again to get vaccinated against Covid-19.

Test-Strategy for the BdP national Jamboree

In addition to the conditions for participation every participant will be required to take part in the mandatory test strategy for the BdP national Jamboree.

Who has to test?

Everyone attending the BdP national Jamboree.

When will tests take place?

Before meeting with your group we need everyone to take a covid-19 rapid test and urge you to only meet and travel with your group if everyone has a negative test result. The control for each group should be carried out by the group leader.

All participants will require a negative covid-19 rapid test result from an official state registered test centre not older than 24 hours upon arrival at the BdP national Jamboree. If it is not possible for you to travel and arrive on the camp within these 24 hours, please contact us and we try to find a solution.



Every participant (vaccinated or recovered) has to test with self tests 2 times over the course of the BdP national Jamboree. The dates to test will be set by each sub camp management. Each group has to bring their own tests.

In addition to that tests will be required if need be.

If a participant is showing cold or infection symptoms we will require them to take a supervised test on the campground.

If someone in your group tests positive, everyone in the group will need to take an additional test to rule out any spread of the virus.

Unvaccinated participants will have to test every day in order to attend the BdP national Jamboree.

In addition to that we are currently working with a local test centre to set up a pop-up test centre for the time of the BdP national Jamboree to make free and accurate tests available on site.

What tests can I use?

The tests you use need to be licensed and listed on the official list of the „Bundesinstitut für Arzneimittel und Medizinprodukte:

How many tests will I need to bring to the BdP national Jamboree?

Vaccinated and recovered participants have to bring at least 2 tests.

Unvaccinated participants have to bring at least one test for every day they will be attending the BdP national Jamboree.

Who is responsible for bringing these tests to the BdP national Jamboree?

All participants are responsible to bring the required number of tests they will need for themselves. You can also purchase those self tests in German supermarkets. In average they cost around 2€ per piece.

Who will take care of the costs of the required tests?

Every participant will have to cover the costs of the required tests themselves, unless their group has found another solution to cover the costs.

What happens in case of a positive test before arrival to the BdP national Jamboree?

In that case it will not be possible to attend the BdP national Jamboree. The person that tested positive will need to access a PCR-test from a state registered test centre and only after presenting a negative PCR-test result the person will be able to attend the BdP national Jamboree.



What happens in case of a positive test while attending the BdP national Jamboree?

If a participant of the BdP national Jamboree tests positive to covid-19 we will isolate the participant. We will organize a test from a state registered test centre as soon as possible.

If this test is negative, the participant will be able to re-join the BdP national Jamboree.

If this test is positive the participant won't be able to re-join the BdP national Jamboree and will stay isolated. In general the participant has to organize their trip home on their own costs or has to be picked up by their caretaker. In the case of our international guests we are still working on a suitable solution for this problem.

What rules apply to day-guests?

The same rules apply to anyone attending the BdP national Jamboree, regardless of the length of their stay.

Covid-19 and the BdP national Jamboree - FAQ

What rules and laws are considered for the preparation and organization of the BdP national Jamboree?

We will comply with all laws and regulations in place at the time of the BdP national Jamboree. Those will include federal, state and communal laws and regulations.

Included will be for example:

- the federal Infection Protection Act
- the covid-19 Protective Measures Exception Ordinance
- the Bavarian Infection Protection Measures Ordinance
- regional measures that might apply
- the protection concept of Jugendsiedlung Hochland e.V.

Will the BdP national Jamboree take place as planned?

What awaits us in the future regarding the covid-19 pandemic is not something we can foresee. While we acknowledge that we might have to re-adjust plans and safety measures, after long and ongoing consideration with experts and the (local) government, at this point in time we expect that the BdP national Jamboree can take place as planned.

Why are we planning with the 3G+ standard and with a mandatory test strategy?

We want to make it possible to attend the BdP national Jamboree as freely as possible while ensuring the health and safety of all participants. Together with the BdP federal board and our hygiene officer we decided, that this strategy will be best to aim for these goals.

What about people that can't get vaccinated due to health considerations?

Especially for people that cannot get vaccinated, for example because of immunodeficiency, we urge everyone that can, to get vaccinated. As scouts we take care of each other, getting vaccinated if we can, especially for those who can't, is part of that. We want the BdP national Jamboree to be a place where every participant can feel safe, no matter their personal health or pre-existing conditions.

When will the final decision be made, if the BdP national Jamboree can take place as planned?

At this point in time we are not able to set a date for this decision. We are still monitoring the situation and will continue to do so. The decision is not only up to us, we will have to take the developments regarding the covid-19 pandemic into consideration and might need to revise aspects of our plans. If the situation demands it, we will cancel the BdP national Jamboree, even though we hope it doesn't come to this.

Do I get my participation fees back if the BdP national Jamboree is cancelled due to the covid-19 pandemic?

Yes! If the BdP national Jamboree has to be cancelled due to the covid-19 pandemic you will get your participation fees back in full.

Do I get my participation fees back if I decide to not attend the BdP national Jamboree due to developments regarding the covid-19 pandemic?

In general: yes. We don't want and can't tell anyone how to personally assess the risks the attendance of the BdP national Jamboree might pose to them. We want to make the BdP national Jamboree as safe as possible and work hard to make this happen. But the decision on how you feel about the measures in place is something you alone have to make. We will support you and figure out a solution either way.

Who's paying the costs that already occurred or will occur?

The BdP is paying those. We try to set everything up as flexible as possible and find solutions with service providers. We try to keep costs low, in case we will have to cancel the BdP national Jamboree. The BdP has a risk reserve that would cover the costs if it comes to this.



Will there be mandatory tests at the BdP national Jamboree? Will there be tests and who will have to take them?

Yes. All information about that can be found in detail in the test strategy for the BdP national Jamboree.

What measures and restrictions might be implemented for the BdP national Jamboree beyond the 3G+ strategy?

The range of possible measures is wide. A lot of them have been implemented or used in the past when cases spiked. For example: restriction of number of participants, access restrictions, mandatory following of the AHA-L rules, more mandatory tests on site, restriction of group sizes, restrictions of attendance for participants from hot-spot regions, increase of hygiene capacities and control through group leaders, possible mandatory isolation after a possible spread on site and if necessary and ordered by local government the abortion of the BdP national Jamboree. ATTENTION: those are possible scenarios to explain what could happen, not one of those measures is in place, ordered or planned at the moment!
